**Notes, TERMS & CONDITIONS:**

1) Single, Couple and Family Intro Memberships are limited to persons that have had no affiliation with the Oneonta Country Club since the 2013 Season. Please note that the Oneonta Country Club's Board of Directors requires that Former Members in possession of an OCC stock certificate surrender their certificate to the Club's Administrative Office in conjunction with this Application.

**NOTE:** Single, Couple and Family Dues rates listed will be locked in for three years. Single, Couple and Family Intro Members who join in September of the previous year may play the rest of that year for FREE (carts not included). Intro Members cannot buy cart packs, bring in an Associate, serve on the Board of Directors or have any voting rights, but they may serve on Committees.

2) New York State Sales Tax will be added to all dues, fees, assessments and other purchases as required by State Law.

3) Initiation Fee (\$1,000.00) and Application Fee (\$250.00) are waived for 2024.

4) Required Fees - MGA/WGA, GHIN and Range Fee will be charged at the time of joining. Minimum Cart Assessment: Annual unspent amount billed October 31<sup>st</sup> will apply ONLY to Single (\*20 carts minimum per Season), Couple and Family Accounts (\*\*30 carts minimum per Season).

5) Statements are sent monthly and payments are due on the 25<sup>th</sup> of the following month. Failure to make timely payment may result in a \$25 Late Fee and suspension of playing privileges.
